Although John Henry Beeson was baptised at Aston upon Trent, the family lived at Shardlow. His father was recorded as a painter at the baptism.

His mother, Mary Beeson, was buried on 12 May 1851, St Peters, Derby. She was 37 years old and lived in Waterloo Street.

On the 1841 census, taken in June, at Waterloo Square, Parish of St Werburgh, Derby were: Joseph Beeson, 35, carpet weaver; John, 5. His brother William Beeson was in gaol.

John appeared at the Police Office Derby in early March 1846:
Thomas Buckley and John Beeson were severally convicted of being rogues and vagabonds and were committed to the House of Correction for fourteen days. ${ }^{1}$

He was just out of gaol when at the Derbyshire Easter Quarter Sessions, at Chesterfield in April: John Beeson, aged 15, and John Tomlinson, aged 16, were charged with having on 30 March last, at the township of Litchurch, feloniously stolen 22 pounds weight of brass, the property of the Midland Railway Company.—Pleaded Guilty—one-month imprisonment. ${ }^{2}$

Then, at the Police Office on 11 July 1846: John Bott and John Beeson were convicted of being rogues and vagabonds and were committed to the House of Correction for two calendar months each. ${ }^{3}$ John continued to be in trouble. At the Police Office Derby on 20 February 1847:
John Beeson, George Johnson, and John Dawes were committed for trial at the next Borough Sessions, charged with stealing 110 lb s of old iron, the property of Messrs. Pegg and Co., from their colour manufactory, in the Morledge, in this town. ${ }^{4}$ At the Borough of Derby Easter Sessions, in April: ${ }^{5}$ John Beeson, 14, George Johnson, 17, and John Dawes, 19, were charged with having on 18 February 1847, at the parish of All Saints, feloniously stolen one hundred and ten pounds weight of iron, the property of Robert Pegg and another. They were all three found Guilty. A previous conviction against Beeson, at the Chesterfield sessions, in 1846, for stealing brass, the property of the Midland Railway Company, having been proved, they were severally sentenced to imprisoned and kept to hard labour for one year each.

[^0]John's brother William was released from gaol in June 1847. When John finished he prison sentence in April 1848, they met up and were quickly in trouble. In July, the pair were committed to stand trial in Staffordshire: William Beeson and John Beeson, charged with stealing one pair boots, the property of Edward Cox, at Burton-upon-Trent. ${ }^{6}$ At the Staffordshire Adjourned Sessions in July:
William Beeson and John Beeson, two brothers, whose appearance bespoke their character, were indicted for stealing a pair of boots, the property of Edward Fox, at Burton. John Beeson pleaded guilty to the indictment; the other prisoner was placed on trial.
It appeared from the evidence of the prosecutor and other witnesses that he kept a shoe stall at Burton market and that on 1 June, the prisoners were seen near the stall. On the following morning, about two o'clock, they were found sleeping in a pig-stye, at Derby, by a police officer, and upon the feet of the younger brother, there was a pair of Blucher boots, without lace holes. The prosecutor and his workman identified these boots as his property, both from the workmanship, and the fact that the holes in Butcher boots sold by him were never punched until sold. The prisoner William Beeson was found guilty. The learned Chairman then told the prisoners that the Court had very little difficulty in dealing with them, for they seemed to be extraordinary persons. On their own declaration, they had been committed five times each. William Beeson twice for vagrancy, once for stealing books, once summarily convicted, and had also been sentenced to seven years transportation, part of which time he had served and was then discharged. The younger prisoner had also been in gaol five times, one instance for a period of twelve months. They were then each sentenced to be transported for fourteen years. ${ }^{7}$

John Beeson, 17, single, can read, a labourer, was convicted on 20 July 1848 of stealing boots at the Stafford Sessions and sentenced to 14 years transportation. He had been imprisoned four times previously. He was received at Millbank Prison on 9 October 1848, from Stafford Gaol, where the gaoler's report was good. John weighed 8 stone 11 lbs ; he said he was born at Shardlow near Derby; and his father Joseph Beeson was a painter living in Liversedge St, Derby.

John was transferred to Pentonville Prison on 3 May 1849. Here he was recorded as a factory labourer, and the gaoler's report was indifferent. A year later, he was transferred to Portland Prison on 1 May 1850. From Portland, he boarded the Hashemy on 19 July 1850 for the voyage to Fremantle. ${ }^{8}$

During the voyage, John was placed on the sick list:
Folio 4: John Beeson, aged 20, prisoner; sick or hurt, diarrhoea; put on sick list, 27 September 1850, discharged 1 October 1850 well.
Folio 4: John Beeson, aged 20, prisoner; sick or hurt, ulcus; put on sick list, 4 October 1850, discharged 8 October 1850 well. ${ }^{9}$

On arrival at Western Australia in October 1850, he was described as:
161. John Beeson, 21, $5^{\prime} 6 \frac{1}{4}{ }^{\prime \prime}$, light brown hair, light hazel eyes, an oval face, fair complexion, stout, marked with smallpox, a painter and single. ${ }^{10}$

General Register:
161 John Beeson, 21, single, Gimp maker, Church of England, went to National School, can read well but his writing and maths are indifferent. John said his father, Joseph Beeson, painter and grainer, Liversedge St, Derby. (A grainer is a painter who specialises in painting inexpensive wood to appear like more expensive wood.)

John received a ticket of leave on 10 November 1851.
On 19 June 1858: 161, John Beeson, ticket of leave, was admitted to Fremantle Prison hospital with a fractured base of the skull. He was discharged on 30 July. When discharged, the register records him as "161 James Beeston, ticket of leave". ${ }^{14}$

He was granted a Conditional Pardon was granted on 13 August 1859.
At the Resident's Court, Geraldton, on 14 July 1881: ${ }^{15}$
William Criddle, John Beeson, and John Beswick were severally charged with infringing the by-laws of the roads board by neglecting to drive their teams double yoked. The charges were admitted, but it was stated in defence that the road board had rescinded the by-law.

[^2]His Worship remarked that the by-law had not been repealed, there was a proper course to observe, and until the by-laws are legally repealed, they must be adhered to. In these cases, His Worship would inflict no fine beyond the cost of summons; but no other case would be allowed to pass. ${ }^{16}$

On 27 December 1889, JH Beeson arrived at Fremantle, per Rob Roy, from Geraldton. ${ }^{17}$ The family possibly moved to Fremantle in the late 1880s as two daughters married at Fremantle in 1890-1.

John applied for relief for his family, at Fremantle, in 1894. ${ }^{18}$
In 1901, the newspaper mentioned: Probates. - Walter Spiller (in the will erroneously called William Spiller), late of Fremantle, carter, died and John Henry Beeson was the executor (Robert Holmes, the other executor, having renounced). Walter has 'adopted' James McGlocklin, a tramster, who was living with him and was commonly known as James Hake. On the death of James, everything was to go to his wife, Trinity Sarah McGlocklin [McLoughlin/McLaughlin] during her lifetime. Trinity was the daughter of John Henry Beeson. Value of estate - $£ 79$ 19s 3d. ${ }^{19}$

Deaths of wife in August 1903. ${ }^{20}$

A year later, John Henry Beeson died in August 1904 at North Perth. ${ }^{21}$
