By October 1848, William Best was no longer a policeman. The Caledonian Mercury reported: About a fortnight ago, as Mr John Muir, bookbinder, was taking a walk on the Queen's Drive towards Duddingstone, he was accosted by an Irishman named William Best, who presented a pistol at his head and demanded delivery of his money. Mr Muir, having refused compliance, the fellow threatened to search his person, but Mr Muir, having raised his stick to deal him a blow, Best stepped aside and desired him to proceed. When Mr Muir had turned about, Best discharged the pistol and made off, leaving Mr Muir unscathed. Nothing more was heard or seen of the fellow till Monday, when Mr Muir recognised him on the North Bridge, and immediately had him apprehended. A pistol heavily loaded, and some powder and balls, were found in his pockets, which he says he carried for amusement. He has been remitted for examination. We learn that doubts are entertained of his perfect saneness.<sup>2</sup>

At the High Court of Justiciary, Edinburgh in January 1849:

William Best was found guilty of theft by housebreaking and assault with intent to rob on the night of 22 August or the following morning. He broke into the premises of Mr Milne, baker, Clerk Street, Edinburgh and stole a quantity of biscuits, two sheets, towels, and other articles. On the night of the 27 August or the following morning, on a public road near Morningside, he attacked and assaulted Thomas (*sic*) Carland, labourer, and Francis Kerr. He brandished a pistol, scaring them both before rifling the pockets of Thomas. Then on the 28 August, on Queen's Drive near Sampson's Ribs, he made a similar attack on William Muir, bookbinder of Edinburgh, and demanded his money and watch. In the course of this trial, the Lord Justice Clerk paid a well-merited compliment to Mr Muir, bookbinder, (one the persons attacked by Best) and to whom his Lordship said the public were deeply indebted for the courage he had displayed on the occasion, and also for the apprehension of the daring offender. 14 years transportation.<sup>3</sup>

William Best, 26, single, was received at Millbank Prison on 20 February 1849 from Edinburgh. His occupation was a Policeman. He was removed to Portland Prison on 31 October 1849.<sup>4</sup> William, 28, boarded the *Hashemy* on the 19 July 1850 for the voyage to Western Australia.<sup>5</sup>

On arrival at Western Australia in 1850, his description was:

154. William Best, <u>20</u>, 5'6", brown hair, blue eyes, thin face, fair complexion, one mole on left side and a small scar left corner of mouth, single and a gardener.<sup>6</sup> His reading was very fair, could write and knew a little maths.<sup>7</sup> He was about <u>28</u>.

Casual Sick, Fremantle Prison.

On 16 November 1850, William presented with diarrhoea. He was treated with castor oil.<sup>8</sup> William received his Ticket of leave on 13 January 1852. He worked for Thomas Smith, stone mason<sup>9</sup> East Perth Cemeteries: William Best, died on 6 April 1852, aged <u>33</u>, of consumption. He was buried on 8 April 1852. William had been in the Colonial Hospital and their records note he died 7 April.

According to one register, <u>William applied for a Conditional Pardon in October 1853</u>, it was due on 10 October 1854, and his sentence expired on 3 January 1863.<sup>10</sup>

## Possibly brother John Best.

He is possibly the John Best who married Elizabeth Kinnear, daughter of Mitchell Kinnear, on 31 October 1848, St Cuthbert's, Edinburgh.
