## William Calderhead, 608, Pyrenees

William Calderhead was born in 1833 in the West Indies, probably Barbados. Prison records show that he lived most of his life in Scotland, but he was not found on the 1841 census. His mother was Ann Tait or Calderhead, and from prison records, William appears to have 1 or 2 siblings.

At the High Court of Justiciary, on 13 December 1847:

William Calderhead and Thomas McCafferie were convicted of stealing a cotton gown. The former, being by habit and repute a thief, was sentenced to seven years' transportation. Thomas was sentenced to twelve months' imprisonment.<sup>1</sup>

The Scottish Criminal Index shows:

William Calderhead, typefounder, Toddrick's Wynd, High Street, Edinburgh, Midlothian, crime was theft by habit and repute at Keir Street, Edinburgh. However, on other prison records, William has no trade or occupation.

Thomas McCaffrey, his co-accused, was a printing press operator, St Mary's Wynd, Edinburgh.<sup>2</sup>

Prison Registers show William Calderhead, 15, single, can read and write imperfectly, has no occupation, was convicted 13 December 1847 at Edinburgh of theft and previous conviction, and was sentenced to seven years. He was received at Millbank Prison on 7 January 1848 from Edinburgh. William had been convicted 9 times previously (six thefts, one disorderly and two vagrancy). On 8 February 1848, he was removed to Parkhurst Prison from where he boarded the *Pyrenees* for the voyage to Fremantle, Western Australia, on 13 March 1851. <sup>3</sup>

William was in prison numerous times as follows. All the places of residence are close to each other, in the old part of Edinburgh.

Records from Scotland's People, Prison Registers

On arrival at Fremantle, Western Australia, on 28 June 1851, William was assigned number 608, issued with a Ticket of Leave and a description taken.

608. William Calderhead, 18, 5'6½", dark brown hair, hazel eyes, long face, fresh complexion, stout, flattened nose, labourer and single. <sup>4</sup>

The Superintendent's Journal shows:

16 July 1851. The following 71 men will be received from the ship *Pyrenees,* and located in No. 3 division of the prison, including 608 Wm Calderhead.

22 July 1851. 40 men with their trades proceeding this day to York, including 608 Wm Calderhead, farm labourer. <sup>5</sup>

Within the next few months, William was in trouble again. On the Half-Yearly Returns of Magisterial sentences on Ticket of leave holders ending December 1851:

608 William Calderhead, convicted of disobedience at York, had his Ticket of Leave temporarily suspended. He returned to Perth Prison.<sup>6</sup>

William appears in the Superintendent's Journal on:

10 December 1851. No. 608 William Calderhead and No. 542 Robert Grundy, received this day from Fresh Water Bay.

6 January 1852. No. 608 William Calderhead will be sent up the country when opportunity offers.

15 January 1852. No. 608 William Calderhead and 594 William McCarty will be released from the Association and forwarded to Fresh Water Bay under the charge of overseer McGall.<sup>7</sup>

A Conditional Pardon was granted in June 1853, and his sentence expired in December 1854.

No further information found on William Calderhead in Australia or his mother in Edinburgh.
